To Qualify

Fax (775) 331-9060 or email to ap@viaseating this completed one-time registration form. Note, these conditions must be met to qualify for SPIFF:

- The completed form must be on file at Via Seating;
- Pricing must be from the most current commercial price list at the time of order;
- Purchase order (PO) must always be clearly marked "SPIFF-Dealer sales person's name";
- If SPIFF is requested on a PO after the PO has been presented, it must be done within 60 days of the order shipment. Via Seating cannot process the SPIFF on a PO after that time.
